Employee Assistance Program (EAP)

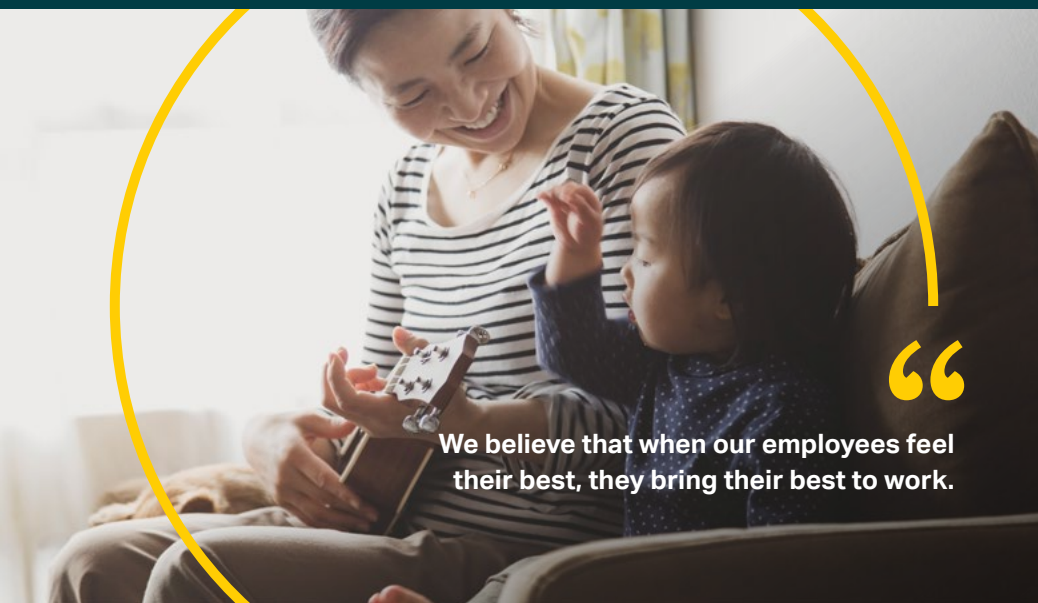
